She reports postoperative pain at 4/10, uses pain medication as needed, and experiences chronic constipation with her last bowel movement occurring prior to surgery. Her past medical history is significant for anorexia, congenital subdural hematoma with chronic seizures, and Raynaud's disease. She resides alone in a condo with a caregiver providing 12 hours of daily assistance and requires help with all ADLs, including grooming, dressing, and bathing. Vital signs are stable, and the surgical dressing is clean, dry, and intact with no signs of infection. She ambulates with a rolling walker and requires contact guard assistance, verbal cues for safe device use, and minimal assistance for indoor ambulation. Physical assessment reveals limitations in strength, range of motion, endurance, standing balance, and overall functional mobility. Her TUG score of 1:07 places her at high risk for falls. She demonstrates tremors in the right hand and decreased fine motor coordination, further contributing to ADL difficulty. Education was reinforced regarding wound care, fall prevention, infection signs, hydration, fiber intake, and the use of stool softeners for constipation management. Her home exercise program was reviewed, including supine therapeutic exercises, sit-to-stand practice, and hourly ambulation. She will continue to benefit from skilled nursing and therapy services, with nursing scheduled to return on postoperative day seven for dressing removal per physician orders.
