Pt is on HH services for SN weekly visit for assessment, blood sugar check and administration of 0.25mg ozmepic. HH PT to improve balance and improve strength. Pt has dementia and requires frequent reminder regarding ambulating safely and using assistive device. Wife is primary caregiver. Nurse performed head to toe assessment. Skin intact. Heart sounds normal, lungs clear, bowel sounds active x4 quadrants. Random blood sugar 174. Denies any recent falls. Nurse administered ozempic injection today 0.25 mg LLQ. Due to connectivity issues, unable to obtain digital signature from pt. Cg signed on paper and nurse uploaded the signature to the EMR. Nurse will continue weekly visits for needs stated above. Physical therapist will perform another evaluation to determine needs.
