Past medical history is significant for osteoarthritis, obesity, allergic rhinitis, hypothyroidism, hyperlipidemia, asthma, obstructive sleep apnea, and anxiety disorder. Skilled nursing is ordered at a frequency of 1 visit per week for 2 weeks, and a physical therapy evaluation has been ordered. On assessment, the patient was alert and oriented to person, place, and time. She reported severe postoperative left knee pain rated 8/10 and is managing pain with oxycodone, acetaminophen (Tylenol), ice, and use of TED hose. She denied shortness of breath, and lung sounds were clear throughout. The patient reported a good appetite; last bowel movement occurred prior to surgery. The left knee dressing was intact with no drainage observed. Functionally, prior to surgery the patient was independent in the home; currently, she requires caregiver assistance for activities involving indoor ambulation due to bilateral lower-extremity weakness, decreased coordination, altered gait mechanics, and postoperative pain. She is ambulating with a walker for safety and requires specialized transportation for community mobility. Bed mobility, transfers, and ambulation currently require moderate assistance. Skilled nursing provided education on effective pain management strategies and reviewed post-left total knee replacement discharge instructions; the patient and spouse verbalized understanding.
