Cozaar - Losartan Potassium 0100mg, take 1/2 tablet (50 mg) by mouth once a day
Menthol-zinc oxide 0.44-20.6% ointment topical as necessary On rash on buttocks
Metoprolol - Hydrochlorothiazide: Metoprolol Succinate 25 mg , take 1 tablet by mouth once a day

Spironolactone - Spironolactone 50 mg 1 tablet by mouth once a day Blood pressure
Oxygen - Oxygen 2 L/min nasal cannula continuous For breathing
