Homebound status: Due to diagnosis of Essential Primary Hypertension , the patient is experiencing decreased endurance and mobility, increasing the likelihood of falls. To safely leave their home, the patient needs assistance from another person and an assistive mobility device.					
Clinical Condition Requiring Homecare:		<div>The patient was referred by the primary care provider for home health services, including skilled nursing, physical therapy, occupational therapy, and medical social work, due to hypertension, constipation, and gait abnormalities. Past medical history is notable for cognitive impairment, hypothyroidism, hyperlipidemia, seizures, obesity, and opioid dependence. The patient resides in a privately owned assisted living facility, where staff assist with activities of daily living, instrumental activities of daily living, meal preparation, shopping, errands, and medication administration. The patient's skin was assessed and found to be intact. Skilled nursing services are recommended at a frequency of one visit per week for four weeks, with the next nursing visit scheduled for Tuesday. A physical therapy evaluation was completed, noting progressive functional decline over the past several years, as reported by the caregiver, including a shuffling gait and inconsistent use of a recently obtained rolling walker. The patient typically ambulates within the assisted living facility without an assistive device and negotiates steps with one railing under staff supervision. Although the patient attends day care twice weekly, she reportedly does not participate in planned activities. On examination, the patient demonstrates generalized weakness with approximately 2-/5 strength in both upper and lower extremities and reduced right upper extremity function, including diminished grip strength. The patient requires contact guard assistance for transfers and short-distance ambulation and exhibits a short step length, absent heel strike bilaterally, and shuffling gait. While using the rolling walker, the patient is able to increase step length with verbal cues. Education was provided to both patient and facility staff regarding safe gait sequencing and cueing strategies. Skilled physical therapy services are recommended to address deficits in strength, balance, and safety awareness to enhance independence and support return to prior level of function. An occupational therapy assessment further identified decreased standing balance and tolerance, reduced bilateral upper extremity strength, impaired task initiation, and limited overall activity tolerance, resulting in reduced independence in self-care, functional transfers, and mobility. The patient previously resided in an assisted living facility and required supervision to minimal assistance with self-care tasks.
