| Clinical Condition<br>Requiring Homecare: <div><span style="font-size: 14px;">The patient is a 71-year-old female admitted to home health services for skilled occupational therapy and physical therapy following a recent hospitalization and subacute rehabilitation stay due to a dislocation of her right prosthetic hip that required surgical intervention. Her past medical history is significant for hypertension, hyperlipidemia, depression/anxiety, fibromyalgia, gastroesophageal reflux disease, glaucoma, and other comorbidities. The patient resides in a basement apartment with her family/significant other. On assessment, the patient was alert and oriented to person, place, time, and situation. She reported well-controlled right hip pain and denied chest pain or shortness of breath. Vital signs were obtained and within acceptable limits. Cardiopulmonary assessment revealed lungs clear to auscultation bilaterally and palpable peripheral pulses in all extremities. Gastrointestinal assessment noted active bowel sounds, with the patient reporting her last bowel movement occurred the previous day. Skin assessment revealed warm, dry, and intact skin without areas of breakdown. Functionally, the patient is ambulatory within the home using a rolling walker and requires contact guard assistance. She requires assistance to transition from sitting to standing and demonstrates contact guard to standby assistance for sit-to-stand transfers and toilet transfers. The patient reports difficulty stepping into the tub to utilize her tub bench and is currently bathing in the shower and at sink-side with assistance. She requires assistance with lower body dressing and utilizes a reacher to support dressing tasks while maintaining hip precautions. Manual muscle testing revealed bilateral upper extremity weakness with strength measured at 3/5. The patient is able to verbalize and recall right hip precautions appropriately. Education was reinforced regarding safety with mobility, use of adaptive equipment, and adherence to hip precautions to reduce risk of re-injury.
