| Clinical Condition Requiring Homecare: <p class="MsoNoSpacing">The patient is a 74-year-old female with a history of bilateral osteoarthritis, status post left total knee replacement 15 days ago, recently discharged from inpatient rehabilitation. She resides with her daughter in the basement of a multilevel townhouse. The surgical incision is open to air with no drainage noted, and the patient reports no pain at rest or with movement. She ambulates short distances indoors using a rolling walker with contact guard assistance due to bilateral lower extremity weakness, altered gait mechanics, decreased coordination, limited endurance, and fear of falling, placing her at high risk for falls. Bed mobility requires minimal to moderate assistance, and transfers to and from the bed, chair, and toilet require caregiver support. She requires standby assistance for upper body dressing and minimal assistance for lower body dressing, bathes at sink side, and was able to access the shower with a step stool under supervision. Sit-to-stand and toilet transfers are completed with contact guard assistance. Bilateral upper extremity strength is reduced at approximately 3+/5 on manual muscle testing.
