Homebound status: Due to diagnosis of Dislocation of internal left hip prosthesis subsequent encounter, the patient is experiencing decreased endurance and mobility, increasing the likelihood of falls. To safely leave their home, the patient needs assistance from another person and an assistive mobility device.					
Clinical Condition Requiring Homecare: <p class="MsoNoSpacing">The patient is an 84-year-old female admitted to home health physical therapy following a hip reduction after dislocating her hip when she bent down to pick up a pencil and fell. She was transported to BWMC by her nephew. The plan of care was discussed and developed with the patient and primary caregiver, both of whom agreed to the proposed PT schedule (beginning 2/5/26: 1x/week for 1 week, 2x/week for 3 weeks [Tues/Thurs], then 1x/week for 5 weeks on Tuesdays). MD Richard Haney was notified of the admission. The patient has a history of bilateral hip and knee replacements, lower extremity arthritis, scoliosis, and osteoporosis. She reports intermittent left-hand joint pain and nighttime tingling. She follows posterior hip precautions per discharge instructions, including wearing a knee immobilizer while sleeping and during transfers, using a pillow between her knees, avoiding hip flexion beyond 90 degrees, not crossing midline, and using a reacher for items on the floor. She lives in a multilevel home with her nephew, who serves as her primary caregiver. Currently, she ambulates indoors with a walker under supervision, performs basic ADLs with minimal assistance or supervision, and requires assistance with IADLs.
