She has since returned home and is being seen for skilled assessment due to generalized weakness and impaired mobility following her acute illness. She denies pain at the time of evaluation. The patient presents with generalized weakness and an unsteady gait, placing her at increased risk for falls. Although specific vital signs were not noted in the provided documentation, the patient was assessed during the visit and demonstrated no acute distress. She resides in the basement level of a row house with her daughter. Both the patient and her daughter are current smokers, which may negatively impact respiratory status and overall health, particularly given her recent pneumonia and underlying metastatic lung cancer. Environmental assessment revealed that the basement living space, including the bedroom, is cluttered and crowded with miscellaneous items, creating potential fall hazards and obstructing safe ambulation with a walker. The patient was educated on the importance of decluttering the bedroom and surrounding areas to establish clear, unobstructed pathways to improve safety and reduce fall risk. Emphasis was placed on maintaining adequate space for assistive device use, proper lighting, and removal of loose items or debris from walking surfaces. Given her medical history of metastatic lung cancer, recent pneumonia, generalized weakness, and unsafe home environment, the patient remains at elevated risk for functional decline and falls. Skilled home health services are medically necessary to address strength deficits, gait instability, endurance limitations, and safety awareness. The plan of care includes continued monitoring of cardiopulmonary status, reinforcement of fall prevention strategies, strengthening and balance interventions as indicated, and ongoing education regarding environmental safety and smoking cessation to optimize respiratory health.
