She has difficulty breathing and has been diagnosed with asthma and emphysema. Reports regular bowel movements. Pt denies fever or chills but temperature was 100.1 today. Discussed signs of infection and pt agreed to seek medical attention if she develops a fever or has any other signs of infection. Head to toe assessment performed by nurse today. Skin is intact. Bowel sounds active x4 quadrants. Lungs clear but diminished throughout. Heart sounds normal. Pt has history of breast cancer. She is taking oral cancer medication but was unable to provide the name (she removed the label). Nurse will follow up with oncologist to obtain the name. All medications reviewed with pt.
