The hospitalization was further complicated by pleural effusion and underlying chronic obstructive pulmonary disease. The patient's past medical history is significant for diabetes mellitus, congestive heart failure, anemia, emphysema, pleural effusion, and gout. At the time of assessment, the patient is adjusting to a new dialysis regimen and demonstrates decreased functional mobility and endurance. The patient resides with family in a townhouse that presents environmental challenges, including six steps without a railing at the entrance and 14 steps to access the second floor. Functionally, the patient ambulates approximately 30 feet on indoor surfaces using a cane with supervision and is able to negotiate 14 steps with a handrail and cane under supervision. Bed mobility and transfers to bed, chair, and toilet are also performed with supervision. The patient is considered homebound due to the significant physical effort required to leave the home, reliance on an assistive device, and a Tinetti balance and gait score of 14/28, indicating increased fall risk. During the visit, the patient participated in therapeutic exercises, including supine hip flexion, bridging, hooklying rotation, straight leg raises, hip abduction, knee extension, and ankle pumps, completing five repetitions of each. The patient tolerated these activities without complication. Skilled physical therapy services are indicated to address deficits in strength, balance, and functional mobility, with the goal of improving independence and safety within the home environment. The plan of care includes continued home-based therapy focused on progressive strengthening, gait and transfer training, and fall prevention strategies, as well as support for adaptation to dialysis-related fatigue and activity limitations.
