She was recently hospitalized due to significant unintentional weight loss over one month, accompanied by nausea and vomiting, and was found to have hypokalemia and hypomagnesemia. She was discharged without a definitive diagnosis and has scheduled follow-up with a new primary care provider as well as an upcoming MRI for further evaluation. At the time of assessment, the patient is alert and oriented to person, place, and time (A&O3). She reports decreased appetite, currently tolerating only small snacks, and her last bowel movement was on 03/13. She complains of knee and back pain and endorses numbness and tingling in both hands and feet, contributing to increased fall risk. The patient is considered homebound due to impaired mobility, need for assistive support, and safety concerns when leaving the home. Functionally, the patient demonstrates a decline from her prior level of function. A few months prior, she was independently ambulatory without an assistive device; however, she now presents with decreased lower extremity strength, with manual muscle testing revealing 3/5 strength in the left lower extremity and 2-/5 in the right lower extremity, limited by right knee pain. She requires contact guard assistance for ambulation and frequently relies on furniture for support. Physical therapy evaluation recommends initiation of skilled PT services to address deficits in strength, balance, and functional mobility, with the goal of restoring independence and safety. A rolling walker has been recommended to improve stability during ambulation, and a request has been submitted to the physician for equipment provision. Occupational therapy evaluation indicates that the patient remains independent with activities of daily living, including dressing, toileting, bathing, and transfers, without the need for verbal cues. Upper extremity strength is within normal limits (5/5 bilaterally); however, decreased grip strength is noted secondary to reported numbness in both hands. Despite this, the patient demonstrates adequate fine motor function for tasks such as fastening clothing and managing medications. No further skilled occupational therapy services are indicated at this time. Skilled nursing involvement is indicated for ongoing assessment, disease process education, and monitoring of symptoms related to colitis, diabetes, and hypertension, as well as reinforcement of safety and fall prevention strategies. The plan of care includes continued skilled physical therapy to improve strength, endurance, and mobility, with close follow-up on pending medical evaluations.
