She resides alone in a senior living apartment with elevator access, with family support provided by her children who rotate caregiving responsibilities. Prior to her recent decline, the patient was independent with all activities of daily living (ADLs) and instrumental activities of daily living (IADLs), ambulated without an assistive device, and was actively driving. Approximately one month prior to assessment, the patient sustained a fall in her bathroom, landing on her left side. Although she initially reported no injury, she developed progressive left lower extremity pain several days later, localized primarily to the left knee, which has since significantly impaired her mobility and functional status. She was evaluated by her primary care provider and subsequently referred to the emergency department due to worsening pain and decreased mobility. During hospitalization, diagnostic imaging including MRI and CT scan reportedly revealed no acute pathology, and her pain was attributed to osteoarthritis. The patient reports that her pain concerns were not adequately addressed during hospitalization, with greater focus placed on management of elevated blood pressure. She was discharged home once her blood pressure stabilized and is scheduled for a repeat MRI of the left knee to further evaluate her persistent symptoms. On current assessment, the patient presents with severe functional decline. She is non-weight-bearing on the left lower extremity, with noted left knee swelling, decreased range of motion, and significant weakness of the left lower extremity. She demonstrates impaired balance, as evidenced by a Tinetti score of 2/28, and is currently unable to safely perform the Timed Up and Go (TUG) test. She requires moderate assistance for all bed mobility and transfers and is unable to ambulate at this time. Endurance is notably reduced. Pain is currently managed with Tramadol, topical diclofenac (Voltaren gel), and use of a hot pack. Vital signs are within normal limits, and skin assessment reveals warm, intact integument. A physical therapy evaluation was completed, identifying significant deficits in strength, balance, range of motion, and functional mobility, contributing to high fall risk and dependence in mobility tasks. Occupational therapy evaluation further reveals non-weight-bearing status of the left lower extremity, decreased standing balance and tolerance, reduced bilateral upper extremity strength, and diminished activity tolerance, all of which are impacting the patient's ability to perform self-care, functional transfers, and mobility-related tasks. Given the patient's marked decline from her prior level of function and current impairments, she demonstrates good rehabilitation potential and is an appropriate candidate for skilled physical and occupational therapy services. The plan of care includes interventions focused on improving strength, balance, endurance, and functional mobility, as well as retraining in ADLs and safe transfer techniques to facilitate return to prior level of function and maximize independence.
