| <p class="MsoNoSpacing"><span style="color:black;mso-themecolor:text1">PT recertification was completed for a patient receiving skilled physical therapy services following a right foot fusion, with treatment focused on improving strength, mobility, and safety. The patient initially demonstrated functional progress as weight-bearing status advanced from non-weight-bearing to weight-bearing as tolerated on the right lower extremity. The patient achieved modified independence with transfers using a standard walker and was able to ambulate up to 50 feet with supervision, including participation in stair negotiation training. However, the patient subsequently developed significant right foot pain, reporting an average pain level of 7/10 despite increased pain medication use. The patient is currently ambulating with a step-to gait pattern using a walker due to pain-related limitations.
