| Clinical Condition Requiring Homecare: <p class="MsoNoSpacing">Patient seen for recertification related to ongoing wound care needs for a right posterior ankle wound requiring skilled nursing intervention to prevent worsening of the wound and infection, making leaving the home a taxing effort. Patient is alert and oriented 3 and lives with family. Assessment revealed a right posterior lower ankle wound measuring 2.9 cm x 2.5 cm with a pink, flesh-colored wound bed and mild swelling noted. Patient reports tenderness to palpation that has improved, minimal pain rated at 3/10, and occasional bleeding down the foot with increased ambulation activity. Minimal drainage was reported while the wound was open to air, with no active drainage or odor noted during the visit. Wound improvement is evident, and the patient independently performs wound care appropriately in the absence of nursing. Patient ambulates with a rollator and cane, remains primarily on the first floor for safety, but is able to access the upstairs shower as needed. No falls, abnormal bleeding, or urinary discomfort were reported. Last bowel movement was yesterday. Patient reports sleeping well and variable appetite. Medications were reviewed with the patient, including actions and potential side effects, with no medication changes reported.
