Her past medical history is significant for cervical spondylosis with radiculopathy, chronic obstructive pulmonary disease (COPD), gastroesophageal reflux disease (GERD), hyperlipidemia, stomach cancer, irritable bowel syndrome (IBS), scoliosis, and recurrent urinary tract infections. The patient continues to experience post-operative neck and shoulder pain, bilateral upper and lower extremity weakness, deconditioning, impaired balance, and decreased functional mobility following surgery. The patient is alert and resides alone in a multi-level townhouse, with family members providing assistance as needed. She currently requires assistance with activities of daily living, including dressing, bathing, meal preparation, cooking, and housekeeping due to post-operative functional limitations. The patient is under spinal precautions, including no bending, lifting, or twisting (BLT), and wears a J cervical collar, with education reinforced regarding proper cervical collar use, adherence to spinal precautions, and the importance of avoiding activities that may compromise surgical healing. Functional assessment revealed impaired bed mobility requiring minimal assistance for rolling and supine-to-sit transfers. Sit-to-stand and toilet transfers require standby to minimal assistance. The patient demonstrates bilateral upper extremity weakness as well as bilateral lower extremity weakness, contributing to decreased endurance, impaired balance, and functional mobility deficits. Gait assessment demonstrated decreased gait speed, shortened stride length, altered gait mechanics, and increased fall risk while ambulating with an assistive device. These impairments significantly limit her ability to safely navigate her multi-level home and perform daily functional tasks independently. Education was provided regarding spinal precautions, safe transfer techniques, fall prevention strategies, proper use of the assistive device, energy conservation techniques, pain management, and the importance of gradually increasing activity while avoiding excessive strain on the surgical site. The patient was instructed to monitor for signs and symptoms of infection, worsening neurological deficits, uncontrolled pain, or other complications and to notify her physician promptly if these occur.
