The patient was admitted to home health services following coronary artery bypass grafting (CABG) x3 with left internal mammary artery (LIMA), left radial artery, and saphenous vein graft harvesting. Upon arrival to the home, the patient was seated in a recliner with his daughter, son-in-law, and significant other present. The patient reported severe pain to the left lower extremity but denied chest pain, shortness of breath, lightheadedness, or dizziness. Vital signs obtained were temperature 97.5F, pulse 77 bpm at the right radial site, blood pressure 122/68 mmHg in the right arm, and oxygen saturation 93% on room air. Patient weight was 189 lb and height was 5'9". Cardiopulmonary assessment revealed lungs clear to auscultation, with no reported respiratory distress. Bowel sounds were audible, and the patient denied nausea or vomiting. The patient reported his last bowel movement was Sunday and stated that he has a longstanding history of irregular bowel movements. His significant other reported that he is taking MiraLAX and Senna for bowel management. Surgical assessment revealed a midline chest incision and three abdominal laparoscopic sites, all of which were dry and intact without drainage. Two vertical incisions were also noted to the lower extremity with steri-strip-type dressings that were clean, dry, and intact. Bruising was present throughout the lower extremity below the knee extending toward the ankle. The patient was noted to have pale skin with light peripheral pulses throughout; capillary refill was less than 3 seconds. No signs of drainage or acute infection were observed at the surgical sites. The patient and family reported that he showered earlier in the day with assistance from his significant other, indicating the need for continued assistance and supervision with activities of daily living during postoperative recovery. Assessment was completed, vital signs obtained, medications reviewed with the significant other, and the patient was admitted to skilled home health services. Skilled nursing will continue to monitor postoperative surgical sites and cardiopulmonary status, assess pain and lower-extremity condition, monitor bowel function and medication effectiveness, reinforce medication adherence and postoperative precautions, provide education regarding signs and symptoms of infection or cardiopulmonary complications, and promote safe recovery following CABG surgery.
