Homebound status: Due to diagnosis of Fracture of unspecified part of neck of right femur, subsequent encounter for closed fracture with routine healing, the patient is experiencing decreased endurance and mobility, increasing the likelihood of falls. To safely leave their home, the patient needs assistance from another person and an assistive mobility device							
Clinical Condition Requiring Homecare:	<p class="p">The patient is a 75-year-old female who is homebound following an elective right total hip arthroplasty on 06/10/2026, with a medical history significant for hypertension (HTN), coronary artery disease (CAD), and hyperlipidemia (HLD). She was hospitalized for surgery and subsequently discharged to a rehabilitation facility, where her recovery was complicated by a gastrointestinal bleed secondary to ulcers. The patient resides with her daughter in a multi-level home with five steps at the entrance and the bedroom and bathroom located on the second floor. She is alert and oriented 3, with clear lung sounds and even, unlabored respirations. The right hip incision is healed and closed; however, swelling is present away from the incision site, and X-rays were obtained at the physician's office yesterday. She denies any additional complaints. The patient ambulates with a rolling walker under supervision on the first floor for approximately 30 feet and with supervision on the second floor for approximately 15 feet while holding onto objects; use of a cane on the second floor has been recommended. She requires supervision for bed mobility, transfers, stair negotiation (14 steps with bilateral handrails), and assistance with bathing and dressing, utilizing a reacher and sock aid for lower body dressing. Upper extremity strength is 4/5 bilaterally. Her Tinetti score of 11/28 indicates a high fall risk, and she requires an assistive device and human assistance when leaving the home due to the considerable effort required and safety concerns. The patient tolerated therapeutic exercises, including supine and standing strengthening activities, and was educated on hip precautions, including avoiding leg crossing, hip rotation, and hip flexion beyond 90 degrees.
