He denies SOB, and lungs are clear throughout. The patient reports a good appetite, with LBM yesterday, and no edema was noted. The patient is using a rolling walker for safe ambulation. SN frequency is 1W12W21W6, and PT/OT evaluations were ordered. Skilled nursing will continue to monitor the patient's condition and reinforce appropriate disease-process management, medication management, safety, fall-prevention strategies, pain management, and when to notify the provider of changes in condition. PT evaluation was completed. Prior to hospitalization, the patient had been ambulating with SPC at a modified independent level and intermittently used a rollator. Following the fall and sustained left femoral neck fracture s/p nailing, the patient currently presents with decreased strength, with bilateral lower extremity MMT measured at 3+/5, and requires supervision for ambulation with a rollator. The patient is primarily limited by a balance deficit and decreased safety with mobility.
