Hydroxyzine Hydrochloride - Hydroxyzine Hydrochloride 25 MG tablet by mouth in the evening

MELATONIN 3 MG / 1 Tablet by mouth once a day

Metoprolol Tartrate - Metoprolol Tartrate 50 MG / 1 Tablet by mouth two times a day

MIRALAX Powder 17GM/SCOOP / Give 1 scoop by mouth every 24 hours as needed

Naloxone Hcl - Naloxone Hydrochloride Nasal Liquid 4 MG/0.1ML / 1 spray nasal as necessary

Senna S - Senna 8.6-50 MG / 1 Tablet by mouth twice a day

Tramadol Hcl - Tramadol Hydrochloride 50 MG / 1 Tablet by mouth every 8 hours as needed

Tylenol Es - Acetaminophen 500 mg/tablet / Give 2 tablet by mouth every 8 hours
